## MINUTES

ATTENDANCE: Jim Stephenson, Chairman; Charlotte Lester; Greg Foster; Chris McClellan; Harold Burnham; Ben Levy; Charles Turner; Jean Carter; Louise Lester; Rich Rothe, Rothe Associates; and Rick Seeley, GPCOG.

1. Call to order. Jim Stephenson called the meeting to order at 7:00 pm at the Town Office.
2. Minutes from May 7, 2002.

MOTION: Jim Stephenson motioned to approve the Minutes as written. Seconded by Charles Turner.
VOTE: Carried.
2. Rick Seeley, presentation, regional cooperation program.

DISCUSSION: Rick Seeley introduced the Committee to the State Planning Office's Interlocal Support Package which includes such things as a map for zoning, watershed boundaries; information on transportation including policies and recommendations which include transportation projects. He continued that GPCOG would help with any information they can give beyond this package notations. He also said that the Central Corridors Coalition of which Raymond is a member will be developing strategies for solving road problems with traffic and access in the future. The Southern Maine Development Council through GPCOG will be discussing improvements in telecommunications. Rick also noted that there was a Wildlife Habitat Area data base which may be of help with our Plan.
3. Town Meeting, Public Participation Plan:

DISCUSSION: Dr. Burnham showed the posters and compositions created by the school children. It was felt that some of the posters and a few of the compositions could be used at Town Meeting and the rest used during the year to help advertise the Comp Plan's work.
