- 2. Approval of Minutes
 - a) March 16, 2021

 - a) Administration no comments

b) Compensation & Training

The large increase is due to the fact that we had not done a market comparison in several years. A pay study was done this year. We are recommending that we do an adjustment each year instead of waiting for every 4 or 5 years. \$4,000 to the Town Manager for the pandemic and there will also be performance bonuses due to the extraordinary efforts of employees during the pandemic. These may be qualified expenses that can be reimbursed. 25 full time employees.

c) <u>Assessors</u>

\$100,000 toward next revaluation

- h) Public Safety Animal Control

Selectman Sadak would like to increase the amount to \$73,000 so we could explore some other avenues instead of sharing with Casco and Naples. Mr Bruno thinks that the contract describes a salaried employee and it appears we are not getting a fair deal in the contract. The intent is to have enough money budgeted to allow the Town the option of hiring our own ACO if it becomes necessary. Our intention is to continue to work with our neighboring towns. ACO calls through Cumberland County Dispatch have been:

2021 thus far	31	104

Dog issues are probably the lion's share of the calls. Some towns charge citizens who have to pick up their dog at the shelter because they were taken there by the ACO.

i) Public Works

Most of the increase is for the Main Street Sidewalk project. Conseca Road, Martin Heights and Panther Pond Pines Road need to be done. We will be doing the other half of Mountain Road this year.

j) <u>Solid Waste</u> – no comments

The increase is due to the change to paying tipping fees for recycling. Right now there is not money to be made in recycling. There was some discussion about ending recycling. We would probably save around \$60,000. There is also the real/perceived environmental benefit to recycling to be considered. A large portion of what we think we are recycling due to cleanliness issues. It still needs to be cleaned before being recycled.

- k) <u>Cemeteries</u> no comments
- I) Parks & Recreation

Selectman Sadak would like to add \$20,000 for public events, movie nights, Halloween events, etc. Mr Oliver said his children enjoyed the Easter Egg event and the general consensus was that it was fun. Possibly look into "break even" events where we recoup costs, possible not charge for the event, only the concessions.

m)Provider Agencies

\$2,000 is in discretionary money that the Town Manager can use for provider agencies.

n) <u>RTP</u>

Mr Bruno it is the same every year with only a handful of riders from Raymond, I suggest \$1,000. Selectman Bullock and Selectman Sadak agree with the \$1,000.

o) Raymond Village Library

They are doing fund raisers to bring in money. Consensus is to approve their requested amount.

p) Tassel Top

Town Manager Willard thanked Joe for the biggest year ever, especially in a pandemic. The cabins are all booked for 19 weeks.

q) <u>TIF</u>

Assessor Lebel is looking into whether or not it could be under the TIF. Town Manager Willard thinks that State grants, etc. would be better for a State-owned property.

r) <u>General Assistance</u> – no comments

s) <u>RSU 14</u>

Select Board Chair Olsen – that is not the final number. The real number will come late in May.

t) Employee Benefits

The health insurance increase will probably be 3.5-4% and there is an increased headcount.

The figure only went down because Raymond's valuation has gone down relative to other towns. The County has not cut their budget.
