Notice of Intent to File**

Please take notice that Port Harbor Holdings, LLC is intending to file an individual Natural Resource Protection Act permit application with the Maine Department of Environmental Protection pursuant to the provisions of 38 M.R.S.A. §§ 480-A thru 480-BB, on or about December 23, 2019.

The applicant is proposing to expand their existing dock system by installing 12 new pilings in order to support additional floating docks, which will provide space for 59 new boat slips. The project site is identified as Lot 34 on Town of Raymond Tax Map 050, which is located at 1328 Roosevelt Trail in Raymond, Maine.

A request for a public hearing or a request that the Board of Environmental Protection assume jurisdiction over this application must be received by the Department in writing, no later than 20 days after the application is found by the Department to be complete and is accepted for processing. A public hearing may or may not be held at the discretion of the Commissioner or Board of Environmental Protection. Public comment on the application will be accepted throughout the processing of the application.

The application will be filed for public inspection at the Department of Environmental Protection's office in Portland during normal working hours. A copy of the application may also be seen at the Town of Raymond's municipal offices.

Written public comments may be sent to the Southern Maine Regional Office in Portland at MDEP, Southern Maine Regional Office, 312 Canco Road, Portland, Maine 04103, where the application is filed for public inspection.
