Staff recommends release of the Town's interest in two separate properties as these accounts are now current. All delinquent property taxes, interest penalties and costs have been paid.

## b) Consideration of signing county tax warrant - Selectmen

Enclosed is a copy of the Cumberland County Tax Assessor's Return for Selectmen's signatures. This is an administrative requirement necessary to collect and disburse the tax due from the Town of Raymond to Cumberland County, which this year is levied in an amount of \$546,353. Although taxes are due on September 1, 2008, there is a 60-day grace period during which interest does not accrue. It is the custom of the town to make payment timed with the expiration of that 60-day period. Accordingly I am recommending that the Selectmen approve and sign the Tax Assessor's Return, which will facilitate payment by the Town of Raymond at the appropriate time.

## c) Department Head Quarterly Report – Code Enforcement Officer Will Cook

The Board of Selectmen recently reinstituted the practice of receiving quarterly department head reports in order to better familiarize themselves with ongoing departmental activities including short and long range goals as well as financial planning. Over the next several meetings, department head reports will be scheduled each meeting until all department heads have had an opportunity to address the Selectmen. These meetings will provide a good opportunity for the Selectmen and the public to become updated on the activities of Raymond's Municipal government by department.

Raymond resident Robert Fogg has requested permission from the town to cross town property located at Map 22, Lot 4 to access the historic earthen and stone dam at the outlet of Raymond Pond for the purpose of securing a Maine Department of Environmental Protection (Maine DEP) permit. The purpose of the permit would be to make certain repairs to restore the integrity of this structure, which would serve to preserve the existing water level of Raymond Pond. Staff has no objection to granting written permission to cross the town property for this purpose assuming that Maine DEP approval of the work can be attained by the Raymond Pond Association, or other legally responsible entity. Plans related to the repair should also be submitted to the town for review and comment prior to any construction activity or access taking place.

Per our conversation, the purpose for my interest is to correct the damage done during the April 2007 Patriot's Day Storm. This is causing unusual water levels for Raymond Pond and excess vegetation growth during low levels of water. This causes many side effects to the health of the lake. If the ownership can be determined, an effort to bring the various lake associations together to possibly correct the dam area and maintain an even lake
