Chairman Mike Reynolds will discuss Raymond's proposed Economic Stimulus Package submittal to Cumberland County. Cumberland County Assistant Manager Bill Whitten is aggregating community requests to put together a county wide municipal government submittal. Raymond provided an outline of three possible projects with the following estimated price tags attached. 1) Commercial scale wind generation project on town owned land (140 acres) located on the top of Patricia Avenue (part of Mount Hunger) at an estimated cost of \$15-\$20 million. 2) Local road reconstruction including work on some state aid roads at an estimated cost of \$10-\$12 million. 3) A combined new town office building, library and community center, to replace the present inadequate and obsolete buildings. The town office was first constructed as a school in 1908. The library was built in 1969 and there is no community center at this time. Estimated cost of a combined new building is \$10 million.

All cost estimates will need to be refined through additional engineering, architectural analysis, etc. Professional technical work has already been done on both the road reconstruction and town building projects which could be made 'shovel ready' very quickly. Commercial scale wind generation would be a goal in keeping with the President's stated infrastructure and construction priorities.



Good morning Bill,

The Raymond Board of Selectmen will have a discussion about possible projects and a formal vote of support for our local economic stimulus package request at their next meeting on February 3, 2009.

Right now Raymond would tentatively request consideration of the following projects:

- 1. Commercial scale wind generation project on town owned land (140 acres) located on the top of Patrica Avenue (part of Mt Hunger) at an estimated cost of 15-20 million dollars
- 2. Local road system reconstruction including work on some state aid roads at an estimated cost of 10-12 million dollars
- 3. A new combined town office building, library and community center to replace the present inadequate and obsolete buildings. The town office was first constructed as a school in 1908, the library was built in 1969 and there is no community center at this time. Estimated cost of a combined new building 10 million dollars.

The cost estimates provided will need to be refined through additional engineering, architectural analysis etc. Professional technical work has already been done on both the road reconstruction and town building projects, which could both be made "shovel ready" very quickly. There is great interest in electrical generation from wind power and we feel that the town may have an ideal site for such an installation.

Thank you for your efforts on behalf of Cumberland County with this work. Please contact me again if you need any additional information.
