Motion to approve issuing a supplemental assessment with a penalty totaling \$581.80 on Map 012 Lot 035 by Selectman Bullock. Seconded by Selectman Taylor.

b) Consideration of Annual Tax Commitment Rate - Curt Lebel, Assessor's Agent

Mr Lebel brought forward 3 options for consideration:

Option 1 – using \$300,000 of fund balance - .75 increase

13.35 Rate	Property Value:	\$125,000	\$250,000	\$500,000	\$750,000

Option 2 - using \$200,000 of fund balance - .85 increase

Option 3 – using \$120,000 of fund balance - .92 increase

Mr Lebel – The majority of the increase is from the RSU #14 budget and the County Tax. Option 1 would use the whole amount approved at Town Meeting to reduce the tax commitment – this would be using about \$100,000 to offset the school and county. Option 2 would only offset the municipal budget and would leave monies for future use.

Town Manager Willard – The charge of the Select Board is to look after the financial health of the Town of Raymond. The county and the school have already factored in their intergovernmental revenues and reserves to come to their final budget. I would choose an option that flattens the tax rate for the Town portion of the budget and that keeps some in reserve for future expenses.

Finance Director Ricker – The estimate for surplus from the audit (which traditionally is used to offset the following year's budget) is \$478,000 with \$317,000 from 6/30/2018 and \$161,000 from 6/30/2019. Bear in mind that the audit is not final.

Mr Lebel – We do not know the figure for the increase in valuation next year. There are several substantial projects that I expect to be completed in the next year of two. I fall in line with Don's thinking that we should use our surplus to mitigate the municipal budget and go with the 2^{nd} option.

c) <u>Consideration of a Resolution pertaining to No Smoking on Town Property</u> – Don Willard, Town Manager

RESOLUTION of the SELECT BOARD

Town of Raymond, Maine
Town of Raymond Tobacco-Free Resolution

The Town of Raymond a resolution to promote the health and safety of Town of Raymond residents by establishing all Town of Raymond recreational area properties as a tobacco-free areas.

Whereas the town of Raymond Maine, has set a goal to be a safe and healthy place to live and work; and

Whereas tobacco use is the single most preventable cause of death and disease in the United States, as well as in the State of Maine; and

Whereas secondhand smoke contains thousands of harmful chemicals and many cancer causing agents, and is a serious health risk to humans, especially infants, children, and pregnant women; and increases a nonsmoker's risk of asthma, heart disease, and lung cancer; and

Whereas chewing tobacco contains many harmful chemicals and cancer-causing agents, and its use is associated with cancers of the mouth, gums, tongue, and throat; and

Whereas tobacco use in and around the Town of Raymond recreational area properties sends contradictory messages to young people who are participating in activities beneficial to their health, while at the same time exposed to the use of tobacco products; and

Whereas the purpose of the Town of Raymond recreational area properties is to provide opportunities for quality recreation and leisure experiences that enhance the quality of life for citizens of Town of Raymond, including providing a safe environment for these experiences; and

Whereas tobacco use and exposure to secondhand smoke are contrary to enhancing the quality of life and providing safe environments; and

Whereas staff and coaches are important role models for the youth that participate in community recreation activities, and whereas what coaches promote is respected and imitated by youth; and

Whereas a policy needs to have procedures to follow when a violation of the policy occurs; and

Whereas the intent of this resolution is to create a tobacco-free environment for youth and not alienate adults who use tobacco products;

Now, therefore, be it resolved that the town of Raymond does hereby declare that its recreational area properties as tobacco-free 24 hours a day, and restricts the use of any tobacco product, including but not limited to, cigarettes, cigars, electronic smoking devices, and chewing tobacco, on, in, or at any athletic facility, playground, or assembly area operated by Town of Raymond. This definition includes all forms of marijuana and includes both recreation and medical marijuana use.

Be it further resolved that:

- Tobacco-free signage will be posted in appropriate areas, and notices will be published in local newspapers to inform the public of this tobacco-free resolution,
- Procedures that reinforce the norm that this property is a tobacco-free facility will be developed, and violations will be addressed in a positive manner.

Section 6. Attendance

Attendance shall be defined as present physically or orally by electronic means. No written or electronic means will be considered attendance (i.e. Skype, telephone, text messages, emails, etc.).

Chair Olsen – This came to light when a request came in for remote participation in meetings. In doing some research we found that the Legislature has considered this a few times and punted on it. By not saying it is approved, they are in effect saying no. We had added this a couple of years ago in the Select Board By-laws and I am suggesting that we remove it until such time that the Legislature makes a decision, with the hopes that the other boards and committees in Town would follow suit. Attendance would only by being physically present. I have 2 issues with using electronic means – if there is a problem with the technology and the connection is lost there may no longer be a quorum, also there can be a bit of a delay which could lead to confusion.

Selectman Bullock – I agree with this.

Selectman Gifford – If there is a quorum physically at the meeting, I think we should allow someone to call in. If there is no quorum, then someone can not call in to make a quorum.

Selectman Bullock – The problem I have with it is the people who elected me to sit here expect me to sit here, not be in Arizona or Florida or wherever.

h) <u>Investigate Recreational Opportunities for the Town of Raymond</u> – Teresa Sadak, Selectman

Selectman Sadak – I stole this idea from Nathan and am running with it. The idea is to have a Parks & Rec Director. Naples and other towns have a similar position. They would be in charge of Tassel Top, Raymond and Crescent beaches, as well as Tassel Top Park and Mill Street Park. They would also coordinate between Raymond Rec Soccer, Basketball, Baseball, Softball, Ski, Swimming, etc. and be a point person for citizens to contact to see how to sign up and get information. Communications from each of the Raymond Rec entities would funnel through the Parks & Rec Director to the new Community Communications Coordinator. Tassel Top Park has trails that must be open to people year-round per the State of Maine. We have a piece of playground equipment that would sink into the swamp if we put it at Mill Street and are looking to put it at Tassel Top Park after a plan has been approved (we are going to have an architect design the area at the recommendation of the State). This person would also work with the PTO, Age Friendly, Raymond Village Library, etc. with their programs.

Chair Olsen – That is the end result. The first step is to pull all of the various groups together to get their input and to study over the winter.

Selectman Bullock – Get all of the stake holders together first before pulling in citizen representatives.

Town Manager Willard – So over the winter Teresa and I will meet with the various groups. We will come back periodically with updates over the winter.

Consensus to authorize the formation of a committee to look into a Parks & Rec Director

i) * Consideration of a Communication Strategy – Teresa Sadak, Selectman

Selectman Sadak – One of the biggest gripes in town is that we are not getting the word out there. People are still filling out surveys and the one with the most response is the Windham Eagle to get news. I am proposing to buy 2 pages of the Windham Eagle once a month for Raymond news. They will set it up, print, and deliver. I am looking for a communications person to coordinate this, update the news section of the Town website and social media pages. This person would work with organizations in the community (Raymond Rec, Age Friendly, Lions Club, etc.) for articles. Kaela has agreed to do this by adding 8 to 10 hours per week (she is currently part-time) and will have the option of doing this work at home. She is also on the PTO which will give information from the school. We are currently paying for notices which we will try to include in these 2 pages.

Town Manager Willard – She will project a very positive image for the Town. This will cost less than the Roadrunner was.

Mr Bullock – My issue is will we have enough meat to include.

Town Manager Willard – We will have the opposite problem with only 2 pages. We will want high quality.

Ms Gonzalez – I am the Vice President of the PTO and as a parent I get all of the flyers from the school, so I will have no problem getting school calendar information. Thank you for allowing me the opportunity.

<u>Town of Raymond – Municipal Meetings Policy</u>

Adopted 10/8/2019

Purpose

• <u>To standardize municipal meeting rules for all Boards, Committees, and Commissions of the Town of Raymond.</u>

Policies

- Meeting Operating Rules All Boards, Committees, and Commissions of the Town of Raymond will operate meetings in accordance with Robert's Rules of Order Newly Revised most recent edition, with the understanding that there may be Town Ordinances, State Statutes, or Federal Laws that will allow or dictate a different procedure (ie: super majority or unanimous votes on certain items, etc.).
- Meeting Minutes (previously a separate policy, approved on December 19, 2006, and amended May 13, 2014 and October 8, 2019) The video/DVD electronic recordings of the meetings are the official records of those meetings (when available) and any written records/minutes would be are supplemental to those video/DVD the electronic recordings unless they are the only record. Any research into the record of a meeting would come from the video/DVD's of that meeting. Copies of the videos/DVD's would be available at the Town Clerk's Office for a nominal fee upon written request. The electronic recordings will be available online within 3 business days of the meeting on the Town Website at www.raymondmaine.org or will be found on YouTube.
