

Exhibit B -

EASEMENT

THE INHABITANTS OF THE TOWN OF RAYMOND, a body corporate and politic under the laws of the State of Maine, whose mailing address is 401 Webbs Mills Rd, Raymond, ME 04071, hereinafter, "Grantor"), grants to SEBAGO FIBER & WIFI LLC, a Maine limited liability company with an address of 824 Roosevelt Trail, #282, Windham, Maine 04062 (hereinafter, "Grantee"), its successors or assigns, the perpetual right and easement, to use in common with the Grantor and others from time to time entitled to use the same, a portion of the land of the Grantor, identified as Tax Assessor's Map 04, Lot 106A, which is more particularly shown in the locations and configuration depicted on the attached plan labeled as **Exhibit A** for the purposes of erecting, installing and maintaining: (i) a structure of approximately 400 square feet to be used as a central office (the "Office Easement Area"), (ii) two new utility poles and underground conduit (the "Conduit Easement Area"); and (iii) and solar panels ("the Solar Panel Easement Area") (altogether the "Easement Areas") for Grantee's installation of a fiber optic network ring connecting all of Grantor's municipal buildings and public safety radio towers, (approximately 16.8 miles of fiber), together with any additional expansion of such fiber optic network as may occur. This easement shall include the right to install overhead and underground utilities as may be necessary for the operation of such central office, along with access to the Easement Areas by Grantee its agents, employees, contractors and subcontractors, along the Grantor's driveway abutting such Easement Area. The Easement Area shall not be relocated, enlarged, reconfigured or modified in

any manner by Grantee without the Grantor's prior written consent.

Grantee by its acceptance hereof for itself and its respective successors and assigns hereby agrees as follows:

- (a) The Grantor shall have the right to use and enjoy the foregoing right and

 Easement Area for the purposes stated in common with the Grantee and others


 legally entitled thereto, but all utilities shall be separately metered and paid by the

 party using the same.
- (b) Any work performed by Grantee related to this easement will be performed in such a manner as to reasonably minimize disturbance of the use and enjoyment of Grantor's property. In the event that Grantee disturbs or damages the Easement Area or any of location on Grantor's property in its exercise of any of the rights set forth herein, Grantee will restore the impacted property to its prior condition;
- (c) Grantee will install additional outdoor lighting to Grantor's driveway in the area adjacent to the Easement Area, at [Grantee's] expense.
- (d) Each party shall indemnify and hold the other party, and its directors, officers, employees and agents, harmless from and against any and all claims, demands, damages, actions, causes of action, or suits at law or in equity, of whatsoever kind or nature, arising out of the exercise of said rights and easements by the other party.
